PRIVACY POLICY STATEMENT

Poliprint Innovative srl, legal offices in Via Mammarella snc, 66100 Chieti Vat no.IT01525040687 (hereafter "The Controller"), as data protection controller, inform you according to the art. 13 EU n. 2016/679 regulation (hereafter, "**GDPR**") who will be able to process, depending on the cases, the following data referring to you and/or reference personnel (employees or colleague) and/or to the business partners or Company managers, or firm or institution that represent, to whom is obliged to communicate the present statement:

1. LEGAL BASES AND PROCESSING GROUND

The processing is necessary to manage the current business contract with you; for this purpose the Controller is in possession of your data qualified as personal data according to the GDPR (ex. name, surname, company name, address, telephone, e-mail, bank and payment details – hereafter "**personal data**" or "**data**") communicated by you in occasion of the contract conclusion for the Controller services, even in the pre-contractual context.

In compliance to the condition provided for the art. 6, par. 1, lett. b), c), d), e) GDPR, we inform you that the awarding of your data is directed to the purpose defined at the point 2) hereafter.

2. PROCESSING PURPOSE

Your personal data are processed even without your expressed consent (art. 6 lett. b), e), f) GDPR), for the following purposes:

 conclude business contracts for services made to the Controller directed to services distribution or products sale;

- fulfill to the pre-contractual, contractual and fiscal duties derived from the relationship with you;

• fulfill to the legal duties, the regulation, the community regulation duty or from an Authority directive (as for example in anti-money laundering matter);

• employ the Controller rights, for example the legal defence right.

3. PROCESSING PROCEDURE

Your data processing is realized by the operations indicated on the art. 4 n.2 GDPR and precisely: data collection, registration, organization, conservation, elaboration, modification, selection, extraction, use, interconnection, ban, comunication, distribution and erasure.

Your personal data are undergo both to the paper and electronic and/or automate processing.

The Controller will process your personal data for the necessary time to fulfil the purpose above mentioned, and even so over ten years from the end of the established relationship linked to the purpose of Service/Supply provided from the supplier.

4. DATA ACCESS

Your data can be accessible to, for the purpose at the point 2 of the present regulation:

• to the Controller employees and partner of Poliprint Innovative srl in Italy and abroad, in their task of officer and/or internal or external processor of the data processing and/or system administrator;

• to third Companies or other subjects (as example, credit institute, professional studies companies, factoring company, professional enterprises, consultant, insurance company, etc.) who manage activities in outsourcing or several nature services on behalf of the Controller, in their task of external processor.

5. DATA COMMUNICATION

Without the necessity of an expressed consent (art. 6 lett. b), c) ed f) GDPR), the Controller can communicate your data for the purpose at the art. 2. to Security organism, legal Authority, Insurance Company for the insurance services, as well as, to those subjects who are compulsory by the law for the fulfillment of the above mentioned purposes. These subjects will process the data as indipendent Controller.

Your data will not be broadcasted.

6. DATA TRANSFER

The personal data are conserved on server located at Chieti Scalo (CH), in the European Union. It is understood that, in any case, the Controller, where necessary, will have the discretion to move the server also in extra-EU. In such case, the Controller assures, starting from now, that the data transfer in extra-EU will be in conformity with the applicable law disposition, prior stipulation of the standard contractual clauses provided for the European Commission.

7. DATA AWARDING NATURE AND CONSEQUENCES OF THE REPLY REFUSE

The data awarning for the purpose at point 2 is compulsory. Without it, we cannot guarantee the contractual services of the point 2.

8. DATA SUBJECT RIGHTS

As Data subject, shall have the rights at the art. 15 GDPR and precisely the rights of:

i. to obtain the confirmation of the presence or not of their personal data, even if not yet registered, and their communication in intelligible form;

ii. to obtain the indication: a) the personal data origin; b) the purpose and the way of data processing; c) the logic applied in case of processing made by the electronical system use d) identification data of the Controller and of processors as in the art. 3, comma 1, GDPR; e) of subjects or subjects category to whom the personal data can be communicated or who can be informed as deputy assigned by the governement of processors or officers;

iii. to obtain: a) the updating, the rectification, namely, when there is an interest of data integration; b) the erasure, the modification in nameless form or the interruption of the data processing for the law data breach, included those who are not necessary to be conserved related to the purposes of the data collecting and furtherly processed; c) the statement that activities as to the letters a) and b) are brought to knowledge, also regarding their content, to whom the data have been communicated and disseminate, except the case where such compliance reveals it impossible or implicates the use of means manifestly out of proportion compared with the protected right; iv. go against, totally or partially: a) for legitimate reasons of the personal data processing who concern you, even if pertinent to the collecting purpose; b) to the personal data processing who concern you for the purposes of advertising material or direct sale or market research fulfillment or marketing communication, by the use of automate system of call without the operator intervention , by e-mail and/or by traditional marketing way by phone and/or by paper mail. It is underlined that the opposition right of the person concerned, expressed in the previous point b), for marketing purposes by automate way is extended to the traditional ones and in any case remain safe the possibility for the person concerned, to exert the opposition right even only partially. Hence, the person concerned may decide to receive only communication by traditional way namely only automate communication or none of both communication typologies.

Where applicable, you have also rights as at the arts. 16-21 GDPR (Rectification Right, 'right to be forgotten', data processing restriction right, data portability right, opposite right), as well as the complaint right to the Warrant Authority.

It is underlined that the interested person has the right to oppose in any moment, for purposes linked to particular situation, to the personal data processing he concerns according to the art. 6, paraghaph 1, lettere e) or f), of the GDPR, included the profiling on the basis of this disposition.

His personal data are not processed for direct marketing purposes. In case the personal data are processed for direct marketing purposes, the interested person has the right to oppose to his data processing at any moment, included the profiling in so far as it is connected with such direct marketing.

9. MODALITIES OF THE RIGHTS EXCERCISE

He will be in the position to excercise the rights at the art. 15 GDPR in any moment sending by his choice:
